Consider Passing Resolution to Appoint a Public Member to the DCA Delta Stakeholder Engagement Committee.

Executive Summary:

The DCA Board adopted Resolutions at its September and October 2019 meetings to establish and appoint the initial DCA Delta Stakeholder Engagement Committee (Committee). At its September 2020 meeting, the Board authorized expanding the number of public members on the Committee to sixteen. Staff targeted filling this new seat with someone that could provide feedback from and outreach to Hood.

Detailed Report:

The Board of Directors established the Committee at its September 2019 meeting and appointed made initial appointments to the Committee at its October and November 2019 meetings. At its September 2020 meeting, the Board voted to expand the Committee to eighteen members with sixteen public members. This new public seat was targeted at increasing outreach to the community of Hood.

Staff publicly advertised for applications to fill this seat, noting the emphasis on finding someone able to provide outreach to Hood. The DCA received an application from Gia Moreno. Ms. Moreno is a resident of Hood and has participated in prior Committee meetings as a member of the public. Her and her family actively involved in the Hood community, and staff recommends that the Board appoint Ms. Moreno to fill the vacant seat.

Recommended Action:

Staff recommends the DCA Board adopt a Resolution to Appoint a Public Member to the DCA Delta Stakeholder Engagement Committee.
